6.3.4. Cleaning Services

6.3.4.1. The Contractor shall clean the following areas, structures and assets in the canals, marinas, beaches and at the King Abdullah Monument, as indicated in Annex 2 (Marine Services and Facilities):

- a. water surface (by removing floating debris and submerged detritus);
- b. shoreline (in a strip agreed upon with KAUST);
- c. breakwaters and other coast protection structures; and
- d. navigational and beach buoys.

6.3.4.2. On the jetties as well as on the sandy areas of beaches and the King Abdullah Monument the Contractor shall pick the garbage.

6.3.4.3. The Contractor shall groom the sand on the beaches and at the King Abdullah Monument.

6.3.4.4. The Contractor shall clean all KAUST- and Contractor-owned marine vessel and boats as necessitated by their use and the weather conditions, including the cleaning of their topside and underwater hull as well as boat sewage discharge.

6.3.4.5. The Contractor shall implement the cleaning Tasks, referred to on Paragraphs 6.3.4.1 to 6.3.4.4 above, with the frequencies indicated in Table 3 below:

Subject of the cleaning	Cleaning frequency
Water surface of the canals, marinas and beaches	daily
Shoreline	
Jetties	
Sandy areas	
Breakwaters and other coast protection structures	weekly
Navigational and beach buoys	monthly
Vessels and boats	as necessary

Table 3: Cleaning frequency

6.3.4.6. The Contractor shall coordinate the cleaning of the rest of the Marine Facilities by KAUST's janitorial contractors.
